## 18/328 **POLICE**

**Talwrn Road Parking Ground -** The Police Officer reported that no further complaints had been received about antisocial behaviour on this site after the entrance gate was restored.

Pen Derwydd Estate - Cllr. Dylan Rees reported that antisocial behaviour was continuing in the lower part of Pen Derwydd Estate because young people had created a route for access to the Dingle Recreation Area. This was causing serious problems of litter, graffiti and use of inappropriate language, affecting nearby residents, who had complained officially to Cllr. Rees.

Cllr. Rees asked the Police Officer to arrange to patrol the area and a suggestion had also been made in the past that mobile CCTV be located there. The Police Officer reported that he would visit the residents who had complained directly, and advise them on the next steps, including phoning 101 immediately when problems occurred.

**RESOLVED** to accept the above and to enquire about ownership of the land at the lower end of the Estate, to look for a way of closing the unofficial route.

#### 18/329 PRESENTATION: PLANNING CONSULTATION – NEW SCHOOL

Cllr. Llinos Jones reported that she had met on 22<sup>nd</sup> February 2019 with an Architect, Anglesey County Council, to discuss the above application, in order to give the Town Council an opportunity to respond to the Planning Department, and any comments made

on the Application at the Planning Committee on 6<sup>th</sup> March 2019. Feedback from Cllr. Jones confirmed that plans were in place for parking provision for Teachers and Parents, together with a Roundabout in front of the School to control traffic.

Attention was drawn to concerns about the application and the Clerk was asked to send comments to the Highways, Waste and Property Department together with the Planning Department, Anglesey County Council, to be put before the Planning Committee, as follows:

- Suggesting that the area near the New School have 20mph zones;
- Ensuring that there was a crossing point near the Roundabout on the B5109 road;
- Suggesting that an area of land be allocated for a path for use by Cyclists/Prams etc. on land near Hen Siop, Rhostrehwfa;
- Suggesting that there were enough Street Lights in this area;
- Being aware that the land near Lôn Cae Garw was prone to flooding and that drainage ditches nearby should be inspected in detail;
- Awareness that the MUGGA Pitch was available for Community use outside School hours.

More information on the application was available on disc.

The Town Council to contact an Energy Saving Consultant, with suggestions for buildings to be considered by a Specialist who would advise which buildings would meet the grant's requirements in terms of energy efficiency.

## 18/337 MATTERS RAISED BY MEMBERS

Cllr. Victor Hughes – The Railway Bridge, Ffordd Glandŵr - Cllr. Victor Hughes reported that six months had passed since the damage occurred to the Bridge, following work by Network Rail to move it. During that time, correspondence had continued with the Highways Department, Anglesey County Council, and it appeared there was difficulty with the Lorry Company's Insurance, which caused delay. Cllr. V. Hughes reported further that he had asked the Highways Department about the rumour the Bridge would not be replaced and that Glanhwfa Road would be re-widened. The old system had worked properly when the bridge was in place, with lorries using the Industrial Estate and not going through the town. Cllr. Victor Hughes asked for the Town Council's support in bringing pressure to bear on the Highways Department and Network Rail to reinstate the Bridge, with a view to reopening the Amlwch line.

Cllr. J. Egryn Lewis suggested this was a matter that Grŵp Adfywio Llangefni could support and provide input on it.

The Town Council was aware that Rhun ap Iorwerth A.S. was lobbying in the Senedd for the reopening of the Amlwch Line, and that he knew of the concerns regarding the situation of the Bridge on Glanhwfa Road.

#### **RESOLVED -**

- (i) To write to the Highways Department, Anglesey County Council, asking what the latest situation was regarding reinstating the Bridge, and pressing them to discuss further with Network Rail;
- (ii) To meet Anglesey County Council Officers to discuss the way ahead;
- (iii) A letter to Network Rail emphasizing the importance of reinstating the Bridge.

  Accept.
- <u>Cllr. Non Parry Sandbags for Flooding Cllr. Non Parry reported that 600 sandbags were available for use by Llangefni residents and that a dry place, under cover and locked, was needed to store them. Members suggested a number of places, with the possibility of storing them in a Container. Cllr. J. Egryn Lewis asked about the old Gas site near the Cemetery. The Clerk reported that correspondence was on going with the Company, to transfer that site into the Town Council's ownership.</u>
  - Cllr. Victor Hughes reported that the Town Council had a duty to make arrangements for the above, and that he would ask a Local Company whether they had a Container the Town Council could use to store the Sandbags.

The Clerk reported he had responded to both requests by explaining that the whole site was at that time under consideration regarding renewal of the Lease Agreement. Because of that, the Town Council was not in a situation to consider any application. The members agreed with the Clerk's explanation.

The MENCAP request also referred to the Pool Table kept in the Clubhouse, and stated that Llangefni Football Club had promised the table to MENCAP, to be put in the MENCAP Môn Hub.

Following a discussion, it was agreed that all the contents of the Clubhouse belonged to the Town Council and because of that the Pool Table was not available to MENCAP, until the Members had seen the Pool Table, reviewed the Clubhouse Inventory and assessed the situation.

Following a discussion, it was - RESOLVED -

- (i) To ask the Clerk to contact Morgan Evans, Valuers and Auctioneers, to get advice on selling the Clubhouse property in its entirety;
- (ii) To assess the Clubhouse and consider whether the contents were of greater value in their current location or if they were sold;
- (iii) That the contents of the Clubhouse did not belong to Llangefni Football Club.

4 <u>Place Shaping, Canolbarth</u> - The Clerk reported receiving an email asking the Town Council to create a list of groups, activities and events where there would be an opportunity to map, as well as a list of Members who would be prepared to do some mapping with Place Shaping Officers.

A Place Shaping Officer was available to call in at the Town Council Office to provide an opportunity for a group of Members to put forward ideas on what they would like to see developing in Llangefni.

Cllr. Non Parry was interested in the above.

**RESOLVED** – Clerk to contact the Officer to arrange a Group Session.

Extending the Cemetery — Cllr. Dylan Rees reported that he was aware discussion had occurred between the Clerk, Deputy Mayor and County Council Officers regarding where to extend the cemetery. The Deputy Mayor confirmed that assistance had been received from Anglesey County Council Officers, including details of a "Cemetery Development Services" Company that specialised in designing, planning and providing a service for planning Cemeteries. Details also confirmed that a number of reviews of the land near the Link Road had been prepared, with copies of the relevant reports available if required. Another option was to use resources already in place with Anglesey County Council Planning Department, following bore holes at the site near the Coleg Menai Roundabout, Penmynydd Road.

Cllr. Victor Hughes reported that four locations were being considered and that it was important to move ahead as soon as possible to agree on a location. The Clerk and
